**POLL RESULTS OF THE ANNUAL GENERAL MEETING
HELD ON 26 JUNE 2026**

The Board is pleased to announce that the AGM was held on 26 June 2026 at 10:00 a.m. and all the resolutions set out in the Notice were duly passed by the Shareholders by way of poll at the AGM.

References are made to the notice of the AGM (the “**Notice**”) and the circular of G-Resources Group Limited (the “**Company**”) both dated 29 April 2026 (the “**Circular**”) in relation to, among other things, (1) the receipt, consideration and adoption of the audited consolidated financial statements and the reports of the directors of the Company (the “**Directors**”) and auditors of the Company for the year ended 31 December 2025; (2) the re-election of the Directors, (3) the authorisation to the board of Directors (the “**Board**”) to fix the remuneration of the Directors; (4) the declaration of a final dividend of the Company for the year ended 31 December 2025; (5) the re-appointment of auditors of the Company and the authorisation to the Board to fix their remuneration; (6) the grant of a general mandate to the Directors to issue new shares of the Company (the “**Shares**”) (including any sale or transfer of treasury shares out of treasury); (7) the grant of a general mandate to the Directors to repurchase the Shares; and (8) the extension of the general mandate granted to the Directors to issue the Shares (including any sale or transfer of treasury shares out of treasury) by the number of the Shares repurchased. Terms used herein shall have the same meanings as defined in the Circular, unless the context otherwise requires.

Results of the AGM

The Board is pleased to announce that at the AGM, all the resolutions set out in the Notice were duly passed by the Shareholders by way of poll.

As at the date of the AGM, the total number of Shares in issue was 450,814,079 Shares, which represented the total number of Shares entitling the Shareholders to attend and vote for or against the resolutions proposed at the AGM. No Shareholder was required to abstain from voting on any of the resolutions at the AGM. No Shareholder was entitled to attend but was required to abstain from voting in favour under Rule 13.40 of the Listing Rules.

The Company's branch share registrar in Hong Kong, Union Registrars Limited, was appointed as the scrutineer for the vote-taking at the AGM. Set out below are the poll results in respect of the resolutions proposed at the AGM:
